Our Goal: Improving Access to Your Library

To ensure all Seattle residents—regardless of age, background or socioeconomic status—have equitable access to the Library's collections, programs and services.

Why we are proposing this

Overdue fines act as a financial barrier to Library access for many in our community. We believe communities are stronger and healthier when everyone has access to the materials they need to pursue life, career and family goals. Research shows that eliminating the practice of charging fines on overdue materials has no significant impact on return rates.

What this would mean for you

You would no longer receive a daily late fine on overdue items, but you would still be responsible for the timely return of your items and payment of lost fees for unreturned items. It could also mean loss of Library privileges until the item is returned or the fee is paid.

Questions and answers:

How do overdue fines impact Seattle residents?

Our research shows overdue fines impact some neighborhoods more than others. While all neighborhood libraries see a similar number of late materials, there are significantly higher account balances and, as a result, more blocked patron accounts in "low opportunity" neighborhoods, as defined by the city.

What would stop someone from keeping books forever if there are no fines?

Patrons would still have their borrowing privileges suspended for unreturned items and they would be charged a replacement fee.

Will the Library clear overdue fines currently owed?

We are considering options, but under the current Levy proposal, there are no plans to clear currently owed fines.

What experience does the Library have with fine-free borrowing?

The Library has quite a bit of experience with fine-free borrowing:

- E-materials—e-books, e-audiobooks, and streaming services—are fine-free.
- Children's materials were fine-free from 1990 to 2009.
- Patrons who qualify for mobile service delivery are exempt from overdue fines.
- Patrons with approved ADA accommodations are exempt from overdue fines.
- We have studied the experience of over 50 U.S. fine-free library systems.

How do overdue fines affect the Library's budget?

The Library collects about \$1.1 million a year in overdue fines. That revenue helps maintain Library operations such as staffing, utilities, books and technology. This revenue has declined by \$226,363 since 2012 as more patrons use digital formats, which are fine-free. Proposed Levy funding to eliminate fines would serve as a revenue replacement for these funds.

Definitions:

- Fines: Amount charged per item, per day for materials not returned by the due date currently \$.25 per item, per day for most materials.
- Fees: Fees assessed for lost or damaged Library materials, card replacements, and interlibrary loans.
- Blocked account: Currently, a patron account that has accrued \$15 or more in fines and/or fees is blocked from checking out or renewing physical materials or using the Overdrive e-book collection. Blocked accounts can still place holds, use Library computers, access subscription databases, and use the Library's streaming media and learning platforms such as Freegal and Kanopy.
